 - Proof of Date of Birth (Birth certificate/ Madhyamik Examination Admit card) (Original and Photocopy)
 - Caste Certificate from competent authority (Original and Photocopy) (if required)
 - PWD Certificate from competent authority (Original and Photocopy) (if required)
 - 10 level (Madhyamik or equivalent) Marksheet (Original)
